## Chicago Chapter News

For those of you who stayed home on October 17 to root for the Bears, and watched Jay Cutler get sacked by the Seahawks defense six times—ha! Chicago chapter members enjoyed an excellent Sunday afternoon playing versions of the *In Nomine*.

The *In Nomine* is an almost uniquely English musical form. John Taverner wrote a mass sometime prior to 1530 on the plainsong "Gloria tibi trinitas," and the *In Nomine* section seems to have captured the interest of other composers. For the next 150 years or more, English composers wrote their own versions of the piece.

Common among them is a *cantus firmus* line, which comes from the original chant. The other lines in the four, five, and six part arrangements are typically rhythmically and melodically complex, weaving around the *cantus firmus*. We played the originator of the style, by John Taverner, and versions by Thomas Preston, Thomas Tallis, two by Robert White, and William Mundy. We closed with a work by Christopher Tye, the most prolific of *In Nomine* composers, with 21 still extant today.

For the November 14<sup>th</sup> meeting, bring your favorites for a Do-it-Yourself session. Take a turn leading the group, or one of our prepared volunteers can lead your music for you. "Seasonal" might be Christmas songs you don't get to play often enough, or Chanukah songs, or something appropriate for Thanksgiving. Almost anything could be included if you've got a creative enough story about why it is seasonal! Bring enough copies for easy reading, at least 10-15.

Also on November 14 we will hear a the madrigal group The Pippens and the Baron's Noyse perform early music from the New World, music composed in Central and South America in the 16th and 17th centuries. In November of 2008 we were treated with a delightful concert with the Pippens, and a big crowd to match.--

### New Benefits of ARS Membership

Recently the American Recorder Society made a few changes to our web page, [www.americanrecorder.org](http://www.americanrecorder.org). If you are a member, you will be able to place classified ads on the site as a free benefit. Nonmembers can contribute items too, but they must pay a fee. Use this space to advertise instruments you would like to buy or sell, music or books of interest, services, or employment. Visit the American Recorder web page, and click **About** and then **Classified Ads** on the left side of the screen.

Also, the web page has long offered an online search tool for finding names and contact information for members across the US and Canada. We now also offer a copy of the full membership list online that can be downloaded as a PDF file. This is a convenient way to look quickly for someone’s phone number, and to see the members sorted by chapter or region. Three versions of the PDF file appear, in alphabetical order by last name, by state and zip code, and by chapter. You will need the account name and password to log on and access these benefits—which you get if you join!

Beyond these new items the ARS offers an excellent web page, featuring:

- study materials, music lists, and booklets about music, dance, and recorder care

Throughout, Bob called our attention to following the flow of each of the voices and especially

Some of you, like me, may have wondered whatever happened to the wonderful collection of medieval arms and armor that used to be on display at the Art Institute of Chicago before they added their new wing and renovated the old exhibit space for the Harding Collection. Some of you, like me, asked them. Or complained. I bet they got a lot of complaints. Anyway, now the Art Institute plans to open a special exhibit November 1 to showcase part of this collection. They also have plans for a large permanent exhibit of their arms and armor as part of a suite of galleries that will also feature the museum’s holdings of medieval and Renaissance ceramics, illustrated manuscripts, jewelry, metalwork, paintings, sculpture, stained glass, and textiles. One of the events related to the special exhibit will be lutenist Joel Spears on December 16 at 6 PM. This free concert and reading, “Once and Future Things: Lute with Literature,” will be in Fullerton Hall. Joel Spears is an instructor at the Music Institute of Chicago and a member of the Chicago Early Music Consort.

## ARS Board Meets near Chicago

The ARS Board gathered September 24-26 in Wheaton and Winfield, IL, hosted by the West Suburban Early Music Society (WSEMS). Members arrived from all over North America; Greg Higby called from Germany.

Five new members attend their first meeting: Nancy Buss, Jeanne Lynch, Mary McCutcheon, Richard Spittel and me. After an orientation for new members Thursday night at Laura Kuhlman’s home in Winfield, we met Friday and Saturday at Gary United Methodist in Wheaton, and on Sunday morning at the Kuhlman’s; Saturday we were in Naperville for a splendid dinner, town hall meeting, and playing session with WSEMS.

Morning meetings started with playing sessions, music propped up on laptop monitors. We devoted much of our time to reorganizing how the ARS works. We created a new set of committees, and then assigned tasks to these committees. Each Board member volunteered to join those of interest. The goal of this restructuring effort was to help make the Board work more efficiently and to set priorities for projects and programs.

For some years, like other non-profit boards, the ARS has struggled with too few people trying to complete too many projects. We sought first to expand the size of the ARS Board and then to streamline its functions. We also sought to identify and address strengths and weaknesses as a Board. For a long time, we have done an insufficient job of membership marketing. While our fund drives have been successful, some of our special projects and priorities haven’t met the needs of all of our members. And some members of the Society see the ARS as not providing them with much value for their annual dues. Thus we set up a Governance Committee to monitor and manage all of the efforts of all Board members; we also created or reorganized committees to focus the Board members’ efforts toward fundraising, marketing and membership services, besides continuing with the current programs that we all value.

The Board also discussed recruiting members and other interested volunteers to help out with Board efforts. These friends would lend specialized types of professional expertise—such as in grant writing, web design, marketing and recruiting—to the Board on short-term projects. We considered improvements to the magazine and the web site, offering more published music to members, and continuing to communicate more regularly with the members and chapter leadership.

We would also like to add staff and move our office from our Administrative Director’s basement. To strengthen the Society’s financial situation, we want to expand our efforts to attract foundation grants and other

large gifts, and look toward setting up an endowment to help fund future operations. Meanwhile, we do not plan to raise membership dues or advertising fees, and plan to continue to publish the magazine five times a year.

I close this article with the stark reality that the ARS, like most arts non-profit organizations, faces significant challenges going forward—issues of decreasing membership and cash flow in an insecure economic climate. But we have a strong team committed to working hard together and devoted to the future. Those of us on the board see the urgency of the situation and want to see the Society prosper. We are looking at ways to appeal to more of the chapter members to join the society, and at ways to reach out to a broader audience. We want to be useful to you; we want to help the chapters continue to enjoy making music together for many years to come.

We lead a community that has been around for over 70 years, and we feel a responsibility to see to it that the ARS continues to lead and serve and promote recorder playing in the U.S. and Canada long after we are gone. To that end, we could use your help. One goal is to encourage members of the local chapters to join the ARS. We need your professional skills and expertise as volunteers for special projects managed by committees of the board. And we need your financial contributions. In turn we look to make the ARS responsive to your needs, a resource that helps you to enjoy recorder playing in your own community.

Many thanks to our friends with WSEMS for hosting our Saturday night pot luck dinner, town hall, & playing session! The ARS Board's next meeting is April 7-9 in Portland, OR (also the site of the 2012 ARS Festival & Conference). We meet September 13-15 in Denver, CO, and in March 2012 in Baltimore.—*Mark Dawson*
